Transcript n. 2 – Teaching exam and overall evaluations.

At 11:00 AM the candidate dott. Viktoriia Lapa presented herself and undertook the teaching exam in English.

To the candidate Viktoriia Lapa, in the remote meeting of May 24, 2022 at 10:00 AM with Faculty and Staff Administration (Recruiting Office) of Università Bocconi, as in art. 4 of the Call for applications, were proposed 5 topics in closed envelopes. The five topics were:

1. Sales Agents and Distributorship Agreements
2. The WTO SPS Agreements and the Relevant Case Law
3. International Protection of Foreign Investments: An Introduction
4. The Notion of 'Worker' under EU Law
5. 'WTO +' and 'WTO X' International Trade Rules

The candidate selected envelopes 1 - 3 – 5 and chose the topic:

'WTO +' and 'WTO X' International Trade Rules

The Committee, after the exam, decides as follows:

The candidate delivered a suitably prepared and well-structured lecture. The didactic material used was considered, concise and clear. She made use of examples usefully connected to major developments in the trade policy of the principal trading powers and developing and recently industrialized countries. Overall, the lesson was balanced and the explanations clear.


Based on this evaluation, after discussion, the committee unanimously proposed to award the Lecturer contract lasting 3 years (renewable) at the Legal Studies Department to:

The Contract starts **1 September 2022**.


