

Disclaimer Olympic Village a.y. 2026-27

The following information is intended exclusively for collecting applications for the allocation of beds at the Villaggio Olimpico University Residence, located within the real estate complex known as “Scalo di Porta Romana” (the “Residence”), managed by Villaggio Scalo Romana S.r.l. (the “Provider”), also through the appointed management entity, Campus X S.r.l. (the “Manager”). Bocconi University performs a purely administrative role in collecting applications and forwarding them to the Manager, remaining uninvolved in any contractual relationship concerning the Residence.

1. Contractual Relationship

The contract for the assignment of the bed and the provision of accommodation services (the “Agreement”) will be entered into exclusively with the Provider, and that Bocconi University is neither directly nor indirectly a party to such contractual relationship.

2. Role of Bocconi

Bocconi University performs solely a technical and administrative activity consisting of collecting applications and transmitting data to the Manager, and does not carry out any activity of intermediation, brokerage, agency, or representation, nor does it assume any obligations or liabilities towards students or the Provider.

3. Disclaimer of Liability

Bocconi University assumes no responsibility whatsoever, under any title, in relation to:

- the negotiation, conclusion, validity, and effectiveness of the Agreement;
- the performance of the Agreement and the quality, continuity, and adequacy of the services provided at the Residence;
- the availability, allocation, maintenance, or conditions of the bed and common areas;
- any breaches, delays, disruptions, or interruptions attributable to the Provider and/or the Manager.

4. Management of the Relationship and Complaints

Any request, communication, complaint, or claim relating to the Agreement, payments, and the stay at the Residence must be addressed exclusively to the Provider or the Manager, with the exclusion of any involvement of Bocconi University.

5. Payments and Defaults

All payments relating to the Agreement are due directly to the Provider and that Bocconi University does not intervene in the management of payments, nor does it assume any responsibility in relation thereto.

I further acknowledge that any delays or breaches may be communicated to Bocconi University within the limits set out in the applicable agreements.

6. Disciplinary Relevance

In the event of delay or non-payment of the fees, as well as in the event of violations of the Residence Regulations or of the Agreement, the Provider and/or the Manager may notify Bocconi University, which reserves the right to assess the situation and, where deemed appropriate, to adopt any measures in accordance with its internal regulations.

7. Acknowledgement of documents

For the online application, it will be necessary that the user has seen and understood:

- the Agreement;
 - the Residence Regulations;
 - the User Declaration.

8. Nature of the Procedure

This procedure does not constitute an offer to the public nor a contractual proposal by Bocconi University, and that the allocation of the bed is subject to the conclusion of the Service Contract with the Provider.

9. Final Provision

Bocconi University assumes no responsibility in relation to the outcome of the application, any failure to assign a bed, or the failure to conclude the Agreement.
