INTRODUCTION TO THE FREE-MOVER SEMESTER



WHAT IS IT?

Students interested in spending a semester abroad without participating in the Exchange program can enroll as **Free-Movers (Fee-paying Visiting Students or Independent Students or Contract Students or Study-Abroad Students)** at some foreign Universities where they can study for **a semester only** in the first or second semester of **their 5th year** (Integrated Master of Arts in Law program).

The **main differences** between the Free-Mover and the Exchange are:

- the **admission process is freely defined** by the host institutions and out of any Bocconi responsibility or involvement;
- the **university fees are to be paid** both to Bocconi and to the host school;
- scholarships are not foreseen for Free-Mover students.



Destinations are updated according to **past-year experiences** and Bocconi application @ Punto Blu opens in **May**.



01. ACADEMIC REQUIREMENTS

WHO CAN APPLY FOR THIS PROGRAM?

Law students enrolled - in the a.y. 2025-2026 - in **their 4th year** of study if:

- ✓ they **satisfy** both **academic/language requirements** (see details below)
- ✓ they are **not selected** for the **Exchange Program 2026-2027** and Themis 2026-2027
- ✓ they were **not selected** for the **Exchange Program 2025-2026** and Themis 2025-2026



MINIMUM

Minimum **100% of 1st year**, **60% of 2nd year** and **60% of 3rd year credits** before semester of departure

ADDITIONAL REQUIREMENTS

- No Bocconi additional academic requirements
- Each hosting School has its **own requirements** which have to be investigated and fulfilled by the applicant.

Students who **withdrew from the Exchange Program cannot** apply for the Free-Mover Semester. Students who are in waiting list for the exchange program can apply for the Free-Mover Semester but, if they **apply** for this **initiative (by reserving a place at Punto Blu)**, their name will be **removed** from the **waiting list** by the Study Abroad staff.

02. LANGUAGE REQUIREMENTS



MINIMUM

- **English:** level **B2** or higher
- Language of instruction of the Host Institution, **if** different from English: level **B1** or higher

The language of selection indicated by Università Bocconi in the Exchange Program destinations is to be considered **compulsory** also to Free-Movers.

Please refer to [this link](#) released for the Exchange Program for specific guidelines on how to satisfy the minimum language requirements.

ADDITIONAL REQUIREMENTS

- No Bocconi additional language requirements
- Each hosting School has its **own requirements** which have to be investigated and fulfilled by the applicant.



03. POSSIBLE DESTINATIONS



The lists of destinations provided on this page are designed to assist current Bocconi students in finding a suitable partner university for the Free-Mover Semester since most of the partner schools do not accept free-movers if they have already an Exchange agreement with Bocconi.

The universities listed in the pdf document "**possible destinations**" are those **who have accepted** Bocconi Students **in the past**. This does not guarantee these schools will accept students in the future.

Schools which inform Bocconi that they do not accept Free-Mover students are listed in the pdf document "**destinations not available**".

Any **other destination** must be endorsed ex-ante, on a case-by-case basis, by the Study Abroad Office. The request, accompanied by a letter of motivation and information material on the University selected (ranking, course offer, language of instruction), has to be presented **before enrolling in the foreign university** as a Free-Mover Semester student and sent to the Study Abroad Office through B in Touch.

04. APPLICATION PROCEDURE & TIMELINE



ELIGIBILITY

- ✓ **Check** if you meet the Bocconi requirements (slide 3 & 4)
- ✓ **Check** if you meet the host school requirements
- ✓ **Ensure** you meet the host school application deadlines and procedures



RULES

Bocconi University will authorize maximum 10 students in each destination available, to recognize their courses taken abroad during their Free-Mover Semester. This number refers to the entire a.y. 2026-2027 (considering both first and second term).

Check the **application steps** available in the next slides to get the info on how to secure 1 of the 10 spots at Punto Blu. Places are assigned on a **first-come-first-served basis**.

By getting the slot at Punto Blu, Bocconi authorizes a student to **recognize** the experience, but this does **not guarantee** that the host University will accept the student' application as Free Mover. If the host University accepts a student' application, but he/she does not have the place at Punto Blu, Bocconi will **not authorize** the recognition of the experience.



APPLICATION STEPS

STEP 1 – BOOK A SLOT ON PUNTOBLU

WHEN?



Application **Open**: **May 5th 2026** at **12 p.m.** (Italian time)

Application **Close**: **February 1st 2027** at **12 p.m.** (Italian time)

WHERE?



At this phase of the application, students do **not** need to **upload any document**. Students are strongly advised **NOT to take any binding financial commitment** without having secured their place for a specific destination at Punto Blu.

APPLICATION STEPS

STEP 1 – BOOK A SLOT ON PUNTO BLU

Access Punto Blu at the following path:

- **ITA:** Mobilità Internazionale > Bandi Mobilità > Ambito Mobilità [Free Mover]
- **ENG:** International Mobility > Mobility Exam Notices > Mobility Area [Free Mover]

Click on **Apply**, read carefully and confirm the mandatory requirements and select your destination.

Please, be aware that **only 1 destination** can be selected at Punto Blu and **a maximum of 10 places per destination** (for the entire Academic year 2026-2027) **for each destination are available**. The 10 places are assigned on a **first-come-first-served basis**.

Once applied at Punto Blu:

- **If successful**, you will be able to display/print the application receipt. The receipt proves that you are within the 10-student cap and that your experience can be recognized.
- **If not successful**, the system will notify in real time if the destination has just reached the 10 students cap.


If a destination – among the ones listed at Punto Blu - is not displayed anymore, it means that the 10 students cap has already been reached. If a student cancels the application for that destination, his/her place will become available again.

By getting the slot at Punto Blu, Bocconi authorizes a student to **recognize** the experience, but this does **not guarantee** that the host University will accept the student' application as Free Mover.

If the host University accepts a student' application, but he/she does not have the place at Punto Blu, Bocconi will **not authorize** the recognition of the experience.





STEP 2 – APPLICATION WITH HOST UNIVERSITY



Once successfully completed Step 1, students are formally authorized to apply directly at the Host university for a Semester as fee-paying visiting students.



Students who decide to apply to a host university **before completing** Step 1 do so **at their own responsibility** and are strongly advised **NOT to undertake any binding financial commitments** (e.g. tuition fees) before successfully completing Step 1 and securing their place at Punto Blu.

Students are advised that:

- the Study Abroad Office does **not** act as an intermediary between Free-Mover students and host universities;
- the Study Abroad Office does **not** provide any signed or stamped document for students' application.

Students can use the Free-Mover Semester **receipt** as a proof that they are authorized to apply at a host university for a semester only.

If students need a copy of their Transcript, is it possible to

- download an **unofficial** copy (issued in Italian) available for free at Punto Blu
- request an **official** copy (upon request, issued in English) subject to charges through Cert@B, accessible through the student's Diary (see [B in Touch > University career certificates and self-certifications](#))



STEP 3 - CONFIRMATION

When students have received a formal admission letter from the host University, they are required to

- **access** once again their application at **Punto Blu** to **upload the required documentation**
- **notify the Study Abroad Office** through [B in Touch > Free Mover](#)

Formal acceptance letter from the host University with a specific indication of the **semester dates** for which you have been accepted
Proof of **Language proficiency** among the ones that are suitable to fulfill the minimum language requirement (**level B2** or higher for **English**, **level B1** or higher for **other languages**), if required

WHEN?




At least 5 working days before departure

The Study Abroad Office will check if students meet the minimum Bocconi academic and language requirements and will send a notification once the recognition platform is available in the yoU@B Diary.

The Study Abroad Office may (or may not) validate the request according to the eligibility criteria. **Only upon receipt of this validation through B in Touch the student is definitely allowed to take part to the Free-Mover Semester experience and register it into his/her career once back.**

05. ACADEMIC RECOGNITION

Study Abroad will provide eligible students with a **Recognition Platform** in their yoU@B Mobility sections once the process is finalized.



PRELIMINARY AUTHORIZATION

After evaluating the offer of the host university, students must verify or request **advance recognition authorization from Bocconi faculty members** by following the procedure described

Please refer to this [link](#) released for the exchange program for further info.



RECOGNITION PROCEDURE

Only at the end of the mobility, after receiving the **transcript**, students can start the recognition of the exams taken abroad by entering a request through the Recognition procedure available in the yoU@B Diary. Please remember that there is no deadline for the recognition procedure, but students need to pay attention to the Study Plan completion date depending on the graduation session they want to join.

Law Free-Mover Semester students can have **a maximum of 5 Bocconi courses** recognized once back from their experience abroad. Students must convert a **minimum of 1 exam** in order for the Free-Mover Semester initiative to be recognized in the academic career.






