COMMITTEE FOR THE COMPARATIVE EVALUATION OF THE CONFERRAL OF N.1 COLLABORATION CONTRACT AT THE DONDENA RESEARCH CENTRE OF BOCCONI UNIVERSITY (CALL N. 11397)

The evaluation committee (nominated on 26/08/2019, prot. n. 13790) composed of Prof. Marco BONETTI (President), Prof. Arnstein AASSVE (Secretary) and Prof. Guido ALFANI (Member), met on 18th July 2019 at 16:00 p.m. in office 6-E3-03 in via Roentgen, 1, Milan.
