

International Politics and Society 2023 Draft Syllabus

Course Description

This course covers the most prominent theories and arguments in international relations and broader globalization scholarship. It places special emphasis on the evolution of social-scientific thinking over international affairs, in order to situate contemporary debates into their historical and geographical context. The varied material presented here is intended to go to first principles, rather than expose you to contemporary cutting-edge empirical research. Nonetheless, based on the material covered in this class, you will be able to situate more recent studies into the traditions from which they emerged and become a more sophisticated consumer—and possibly producer!—of international affairs scholarship.

Assessment

Response Papers (60%): All students will write two 2-3 page papers reacting to a subset of weekly readings (to be divided during the first class, depending on the number of students and their interests). These papers are not summaries; students should address and criticise the core issues covered in the reviewed articles, aiming to raise 3-4 interesting questions through further reading, critique, comparison, and so on. Response papers are due a day before the relevant class and will form the basis of a short presentation in class and subsequent chairing of the discussion.

Review Paper (40%): At the end of the course, you are expected to employ the knowledge you have amassed to review a relatively recent book or small collection of thematically coherent articles on international relations or globalization. This review is intended to provide a springboard for exploring a theoretical issue or empirical puzzle that interests you. The review should be 3,000-4,000 words, excluding references. **Deadline TBC.**
