The candidate responded by illustrating her current and future professional goals and showed a very coherent profile with excellent knowledge and competences in the areas required by the project. The interview ended at 9.15 am.

The Commission proceeded with conference call with the candidate Stefano Testoni at 12.15 pm upon verification of his identity. The candidate was asked to discuss his professional path. The candidate responded proficiently, although the interview highlighted that his projects and research interests lie outside the areas required by the project.

The Commission proceeded to evaluate the interviews according to the previously established criteria, and assigned the following scores

Elisabetta Listorti: 40 points

Stefano Testoni: 30 points

Therefore, given the previous evaluation of the CV, academic and scientific titles, publications and the interview, the total score is as follows:
