The candidate responded by illustrating her current and future professional goals, her attitude towards team work, and showing a coherent profile with the areas required by the project as well. She inquired about the social cohesion in the group.

The interview ended at 15.20.

The Commission proceeded with the conference call with the candidate **Di Giovanni** at 15.21 and verified his identity.

The candidate was asked to outline her goals during and after the postdoc, plans for collaboration in Bocconi, a description of technical work, and what dish they would bring to a group dinner. The candidate responded by illustrating her current and future professional goals, her attitude towards team work, and showing a coherent profile with the areas required by the project as well. The candidate inquired about the number of people in the lab and joint work with Prof. Zecchina.

The candidate inquired about supervision possibilities with students.

The candidate was asked to outline her goals during and after the postdoc, plans for collaboration in Bocconi, a description of technical work, and what dish they would bring to a group dinner. The candidate responded by illustrating his current and future professional goals, his attitude towards team work, and showing a coherent profile with the areas required by the project as well. The candidate inquired about teaching and mentoring opportunities and a typical week in the lab.

The interview ended at 16.23.

Lauscher, Anne:

Excellent preparation, strong impression of a career vision throughout the position and thereafter. Demonstrated good technical knowledge and awareness of the field.

Di Giovanni, Marco:

Technically strong candidate, with good motivation for the position, but a slightly different background.

Ramponi, Alan:

Promising candidate with good impression of a career vision throughout the position and thereafter motivation for the position.

Cercas Curry, Amanda:

Technically strong candidate, slightly unclear motivation of career vision, excellent motivation for the position.


The Commission unanimously declares the candidate **Anne Lauscher** to be the winner of the competition with effect from **September 01, 2021**.
