Second year - a.y. 2027-28

- Research activities;

- seminars organized by the Legal Department, conferences (as a listener and as a speaker), Teaching/Teaching Assistantship/Research Assistantship activities (optional);
- in the 2nd semester of their 2nd year, PhD students are encouraged to spend at least one period of stay abroad in order to develop their research project under the supervision of international professors or experts in their field of study.

Requirements to pass to the next year

Favourable assessment of the items below by the student's advisor and another member of the faculty:

- Draft chapter/article;
- Progress report detailing the progress of the research.

Third year - a.y. 2028-29

- Seminars organized by the Legal Department, conferences (as a listener and as a speaker), Teaching/Teaching Assistantship/Research Assistantship activities (optional);
- thesis submission to external reviewers (end of 3rd year);
- thesis discussion.
