DUGHERA Stefano: the candidate responds exhaustively, showing good knowledge of the literature but limited technical expertise in the areas required by the project.


TSIARAS Konstantinos: the candidate shows sufficient knowledge of the literature but very limited technical competence in the areas required by the project.

The Commission unanimously declares the candidate **BELLODI LUCA** to be the winner of the competition with effect from **1 September 2020**


The Commission passed this report to the Faculty and Research Division of Università Commerciale Luigi Bocconi for subsequent compliance.


