The candidate responded proficiently, showing that she masters comparative tools. Her fit with the project is very good.

Finally, The Commission proceeded with the candidate Davide Zecca at 4 p.m. The candidate was asked to discuss his possible contribution to the project starting from his previous studies and publications. The candidate responded very proficiently and showed an excellent fit with the project, by suggesting possible lines of research that may improve the final result.
