The candidate was asked to illustrate his professional career and his competence on the skills required by the research grant. The candidate responded in a satisfactory way, showing good skills for the areas required by the project.

The interview ended at 10.30 pm.

The Commission proceeded with a conference call with the candidate Marsi Antonio at 10.35 am and verified his identity. The candidate was asked to illustrate his professional career and his competence on the skills required by the research grant. The candidate discussed satisfactorily his professional career, but showed inadequate skills for the areas required by the project. The interview ended at 11:00 am.

The meeting ended at 11.15 pm.

The Commission proceeded to evaluate the interviews according to the previously established criteria, and assigned the following scores:

Overall assessment:

Maffei Faccioli Nicolò: the candidate shows very good skills.
