## Overall assessment:

<u>Bellardini Luca</u>: the candidate shows a more than good competence, covering the different fields included in the research project, but he does not match completely the searched profile.

<u>Giakoumelou Anastasia</u>: the candidate shows a good competence but she does not match completely the searched profile.

**<u>Zurowska Evelina</u>**: the candidate shows a good competence but she does not match completely the searched profile.

The Commission unanimously decide not to declare any candidate as the winner of the competition.
