#### ART. 1

#### ART. 5

The judging panel will be made up of members appointed by **Intesa Sanpaolo** and members appointed by **Universita' Bocconi**. The following criteria will be used in judging the applications:

- analysis of academic and professional records
- certification, training courses, publication of articles, etc.....
- reference letter(s)
- motivational letter
- results of any interviews held by Intesa Sanpaolo
- family economic condition

#### ART. 6

The panel's decision will be considered final. The assignment of the scholarship will be formally notified to the beneficiary by the Commission through an assignment letter, no later than the starting date of the **2012/2013 Mafinrisk** Edition.

Failure to accept the scholarship, as well as failure to enrol in the **2012/2013 Mafinrisk** Program by the date stated in the notification letter, would determine the loss of the scholarship.

#### ART. 7

Tenure of the scholarship will be for the duration of the Course and disbursement of the same will be effected by **Intesa Sanpaolo** at the conditions provided by **Intesa Sanpaolo** in accordance with the dates of the installments of the tuition fees for the Course. Tenure of the scholarship is subject to the regular completion of the **Mafinrisk** program.
