THEMIS REQUIREMENTS

Themis students are required to take and enroll in **at least 30 credits** worth of courses and pass at least 24 exam credits during the semester abroad. Courses must be selected from a list of Themis accredited courses;

THEMIS students may select one course (up to 6 ECTS credits) outside the THEMIS course list, choosing either from the list of suggested courses below or from Bocconi's general course offering, provided that the selected course is available and open to incoming exchange students. Themis students who do not respect the Themis program study plan requirement will be required to change their study plan.

COURSE SELECTION

Course selection will run from August 24 to 26, 2026 and courses are assigned on a first-come first-served basis. Classes will start on September 2, 2026. Students will have the possibility to change their study plan during the Add/Drop period September 7-15, 2026 (upon courses availability). After the deadline (September 15, 2026) changes (add/switch/drop) are not allowed.
