## Minutes 1

The Judging Committee of the competition by exam and academic titles for 1 spot for a Research Grant related to sector ECONOMY OF FINANCIAL INSTITUTIONS AND CORPORATE FINANCE (Scientific Sector 13/B4) with a duration of two years at the Research Centre GREEN of Università Commerciale "Luigi Bocconi" of Milan is made up of:

- prof. Marco Percoco, Associate Professor with tenure
- prof. Paola Castelli, Senior Lecturer
- prof. Claudio Zara, Researcher and Adjoint Professor with tenure

It met on Oct. 14<sup>th</sup> 2020 at 2 pm (CET) in room SR 2-C4-SR02 at Bocconi University to decide the scores to assign to the research and academic titles and publications.

The Committee had appointed Prof. Marco Percoco as President and Prof. Claudio Zara as Secretary.

The Committee took note of the regulations set out in the notice of competition that the maximum points might be assigned are as follows:

- 30 points out of 100 for the evaluation of CV, academic titles and research and programming experience;
- 30 points out of 100 for the evaluation of scientific publications presented and the "Document to pursue the research";
- 40 points out of 100 for the evaluation by interview.
- 100 points out of a total of 100

Only candidates who achieve a minimum of 40 points in the evaluation of titles, publications and project will be admitted to be evaluated by interview.

Having read the applications and titles submitted by the candidates of the competition, which were all compliant with what was set out in the competition notice, the Committee assigned points as follows:
