The Commission proceeded with conference call with the candidate Aliashgar Bahoo Torodi at 5 pm upon verification of his identity.

The candidate was asked to discuss her professional path. The candidate responded by illustrating his current and future professional goals and showed a very coherent profile with excellent knowledge and competences in the areas required by the project

The interview ended at 5.15 pm.

The Commission proceeded with the conference call with the candidate Silvio Traverso at 5.20 and verified his identity.

The candidate was asked to discuss his professional path. The candidate responded proficiently and showed a good fit with the project, although the interview highlighted that his projects and research interests lie outside the areas required by the project.

The interview ended at 5.35.

The third candidate Saptorshee Kanto Chakraborty did not connect at the scheduled time. The Commission waited until 6 pm and then concluded the session.

The Commission proceeded to evaluate the interviews according to the previously established criteria, and assigned the following scores:


The Commission unanimously declares the candidate **Aliashgar Bahoo Torodi** to be the winner of the competition with effect from **1 September 2020**
