

MINUTES OF THE SELECTION COMMITTEE MEETING OF THE COMPETITION FOR THE CONFERRAL OF N. 1 PRIVATE LAW CONTRACT OF A FIXED-TERM "LECTURER" FOR THE COMPETITION SECTOR 13/D4 AT THE DEPARTMENT OF "DECISION SCIENCES" OF THE LUIGI BOCCONI UNIVERSITY OF MILAN

Minutes n. 1

The Committee meeting, convened by prof. Pierpaolo Battigalli, Director of the Department of Decision Sciences, was held, via an online call, on June 13th 2022 at 11:00 am.

The Committee is in charge of the comparative evaluation for the conferral of n. 1 fixed-term private law contract as "Lecturer", announced by the Luigi Bocconi University on April 22nd 2022, prot. n. 4594, for the competition sector 13/D4. The Committee convenes for the evaluation of the applications received and the identification of candidates to be admitted to a trial academic lesson.

The Committee takes note that 2 applications have been duly submitted. They have been evaluated based on the criteria listed in the competition announcement. In order to possibly invite candidates to give an academic lesson to conclude the comparative assessment, the curricula, the list of publications and the qualifications presented by each candidate were preliminarily evaluated.

The teaching profile required by the announcement regards courses concerning the Mathematics Methods for Economics and Actuarial Science. In particular, in light of the educational needs expressed by the Department of Decision Sciences, the Committee takes in special account the Mathematics and Mathematics for Economics topics, to be delivered in English, and the areas characterizing the candidates disciplinary interests, skills and teaching. The Committee also notices a significant teaching experience.

Based on this evaluation, the Committee formulates the following judgments:

Gianmario Massari:

The candidate obtained a degree (Laurea) in Information Sciences from the University of Milan. The curriculum highlights a wide-ranging educational activity, though it does not show the achievement of a PhD degree or the presence of scientific publications. Consistently with this, the candidate does not attach publications to his application. It is inferred from the attached curriculum that his teaching activities have mainly concerned the areas of Theoretical Computer Science, Applied Statistics, and the use of Personal Productivity Software. Despite the value of these activities, they are not particularly relevant to the areas relating to this competition. Therefore, despite a valuable profile, the candidate does not seem suitable to fill

the position object of the announcement and the commission unanimously decides not to admit him to the trial academic lesson.

Fabio Tonoli:

The candidate obtained a PhD in Mathematics from the University of Padua and a Degree in Mathematics from the University of Milan. He is currently an Academic Fellow at Bocconi University and covered a similar position at the University of Milan. The candidate's teaching activities spanned different topics in Mathematics and Mathematics for Economics (about twenty different courses, most of which strictly related to the the current competition). The research activities focused on geometry and operations research and they were published in good journals. The commission gives a very positive evaluation of the candidate and considers him of great interest for the position that is the subject specified in the call. Thus, the commission unanimously decides to admit the candidate to the trial academic lesson.

Following the expressed judgments, the Committee decides to admit the following candidate to the trail academic lesson (to be held online on June 29th 2022):
