The Judging Committee for the competition based on academic titles and examination for no. 1 position of research grant holder relating to the competition sector 12/A1 Private Law with a duration of three years at the Department of Legal Studies of Università Commerciale "Luigi Bocconi" in Milan, consisting of:

met on 30 September 2020, at 13:00 a.m., through conference call arranged on online platform for the interviews, admitted to the oral exam in the selection made on 21 September as per the previous minutes.

The Commission has acknowledged the rules established in the field of public competitions by art. 6, 8, 11, 15 of Presidential Decree 487/1994, as amended and supplemented by Presidential Decree 693/1996.

Candidates are summoned by the Commission in the following order:

- BUONANNO LUIGI
- PATRONE MATTEO

The Commission proceeded with conference call with the candidate Luigi Buonanno at 13:05 and verifies his identity.

The candidate was asked to discuss a publication on State liability. The candidate exposes the basic lines of reasoning of his contribution and answers to the questions of the Commission demonstrating a deep knowledge of the scrutinized topics and a complete mastery of the terminology used within the specific sector of private law. The candidate further demonstrates that his competences embrace also the topics affected by the research project, especially with regard to the law of obligations and of personal guarantees. The interview ended at 13:28.

The Commission proceeded with the conference call with the candidate Matteo Patrone, at 13:30 and verified his identity.

The candidate was asked to expose one of his publications in the context of trust. The candidate demonstrates a good knowledge of common law legal practice and of the case law developed on *in terrorem* clauses within testaments. He also tackles the problem of the legitimacy of such clauses within the Italian legal system, demonstrating a good knowledge of conceptual categories. The candidate further demonstrates that his competences could embrace also the topics affected by the research project, although he lacks a specific knowledge on personal guarantees.

The interview ended at 13:55.

The Commission proceeded to evaluate the interviews according to the previously established criteria, and assigned the following scores:

Overall assessment:

Buonanno Luigi: The candidate presents academic and research qualifications of high level. He spent study periods abroad in important research institutes, as the *Max Planck für ausländisches und internationales Privatrecht* of Hamburg and the *Institute of Comparative and European Law* of the Oxford University. Moreover, he was granted with scholarships and with the (ELI) ‘Young Lawyers Award 2019’ assigned by the *European Law Institute*. Il candidato ha inoltre partecipato a convegni di rilevanza nazionale e internazionale. In addition, the candidate has participated in national and international conferences.

His publications are all coherent with the scientific disciplinary sector “12/A1”. The contributions are mainly published in top ranked law journals. They demonstrate a great variety of interests – in the fields of obligations, contracts, civil liability and prescription – and a significant methodological accuracy. The experiences and the issues tackled within the publications integrate an adequate basis in order to fulfill the research granted by the 3-years research grant.

The oral examination confirms the capabilities and the preparation of the candidate, who answers to the questions, demonstrating a deep knowledge of the scrutinized topics and a complete mastery of the terminology used within the specific sector of private law. In the course of the oral examination, the candidate further demonstrates that his competences embrace also the topics affected by the research project, especially with regard to the law of obligations and of personal guarantees.

Patrone Matteo: The candidate presents academic and research qualifications of good level. He received a PhD at the University of Pavia in private law, Roman law and European legal culture in 2017. In 2015, he received a Master degree on the law of trusts at the University of Genova. In the same University, he was holder of a research grant from 10/2010 to 9/2011. He was also holder of another research grant at the European University (Università Europea) in Rome during the a.y. 2018/2019.

His publications are all coherent with the scientific disciplinary sector “12/A1”. The contributions demonstrate an adequate level of scientific analysis and a good editorial positioning. However, they are almost only devoted to issues related to trusts. Significant connections to the topic of the research of the present recruitment proceeding are therefore absent.

In the course of the oral examination, the candidates demonstrates good knowledge of common law legal practice. He tackles the issue of the admissibility of clauses often adopted in Anglo-American legal systems within the Italian legal system, showing a good knowledge of the conceptual categories. The candidate further demonstrates that his competences could embrace also the topics affected by the research project, although he lacks a specific knowledge on personal guarantees.

The Commission unanimously declares the candidate Luigi Buonanno to be the winner of the competition with effect from 1st November 2020.

The Commission passed this report to the Faculty and Research Division of Università Commerciale Luigi Bocconi for subsequent compliance.
