Transcript n. 2 – Teaching exam and overall evaluations.

On July 13th at 2:00 PM the selection committee met online for the comparative evaluation and selection of n. 1 "contratto di diritto privato di lavoro autonomo a tempo determinato di "Lecturer" Department SOCIAL AND POLITICAL SCIENCES sector 13/C1, scientific sector SECS P/12 the call for applications was issued by Università Luigi Bocconi on May 18th prot. n. 15095.

Prof. ANDREA COLLI is the President of the committee.

According to the evaluation at the end of the JUNE 21st 2021 meeting, the following candidate is admitted to the exam

- Dott. MARINA NICOLI summoned at 2:00 PM

At 2.05 PM the candidate Dott. MARINA NICOLI is present and sustains the teaching exam in Italian and English.

To the candidate MARINA NICOLI, in the meeting of July 12th 2021 at 1:00 PM with Faculty and Staff Administration (Recruiting Office) of Università Bocconi, as in art. 4 of the Call for applications, were proposed 5 topics in closed envelopes. The five topics are:

- 1. The great divergence and the emergence of Europe**
- 2. The "great transformation": the first industrial revolution**
- 3. The first major global crisis: the 1929 crisis and its consequences**
- 4. The second industrial revolution: new strategies and new business structures**
- 5. The industrialization and development models of the late comers countries**

The candidate selected envelopes 2 - 3 - 5 and choose the topic:

3 - The first major global crisis: the 1929 crisis and its consequences

The Committee, after the exam, rules as follows:

“The candidate has completed the assigned lecture in an appropriate, clear and convincing way. She has been able to make appropriate references to the present, showing how history can be useful in interpreting present events. In the short time span provided, she has been able to provide a clear synthesis of the topic, and shows an in-depth knowledge and competences in the fields of economic and business history.”

Based on this evaluation, after discussion, the committee unanimously proposes to assign the Lecturer contract lasting 3 years (renewable) at the SOCIAL AND POLITICAL SCIENCES Department to Dott. MARINA NICOLI.

The Contract starts **September 1st 2021**.
