According to the criteria listed in the call, candidates Mao and Mura have been admitted to the interview that will take place on 27th January 2021, from h. 10:30 to 11 via conf call.

Interview meeting

The Committee confirms that the interview of candidate Omissis took place at 10:30 on 27th January 2021.

The commission asked the candidate about her curriculum vitae, her research path, the degree of in-depth study of cultural management issues and questions aimed at investigating the requirements of the position.

At the end of the interview, the Commission unanimously expresses a positive opinion and assigns a score of 45 points. The candidate appears motivated, with a vocation for research in the entrepreneurial field, but with a specific attention paid to digital platforms both as an object of research and as an area of data collection; cultural management issues are marginal to her interests and lacks a specific knowledge of artistic projects as business organizations.

The Committee confirms that the interview of candidate MURA MARGHERITA took place at 10:04 on 27th January 2021.

The commission asked the candidate about her curriculum vitae, her research path, the degree of in-depth study of cultural management issues and questions aimed at investigating the requirements of the position.

At the end of the interview, the Commission unanimously expresses a positive opinion and assigns a score of 60 points.

At the end of the interview, the Commission expresses unanimously the following evaluations:

- Omissis : positive. The candidate is grappling with innovative topics and research methods in the field of entrepreneurship, but without a focus or specific experience relating to the subject of the call. It therefore appears less coherent than the profile sought; moreover, it is possible that the effort required to deepen cultural management and cultural entrepreneurship issues is not so useful for the research trajectory of the candidate.
- MURA Margherita: very positive. Research interests and previous experiences focus on the theme of the relationship between artistic growth and sustainability; the candidate is building an individual professional path aimed at safeguarding the specificity of cultural and artistic projects within a sustainable business project, be it a company, an institution or a young entrepreneurial reality. With respect to the requirements of the call, it is therefore a very focused profile.
