

## COMMITTEE FOR THE COMPARATIVE EVALUATION OF THE CONFERRAL OF N. 1 COLLABORATION CONTRACT AT BAFFI CAREFIN RESEARCH CENTRE OF BOCCONI UNIVERSITY

### MINUTES

The evaluation committee composed of Prof. Donato Masciandaro (President), Prof. Gianmarco Ottaviano (Secretary) and Prof. Carlo Altomonte (Member), nominated on August 28th, 2020, prot. n. 28174 met on September 11<sup>th</sup>, 2020 at 11:00am via conference call.

According to the regulations of the competition, the Committee has concluded that the maximum scores to be allocated are as follows:

- 30 points out of of 100 for the evaluation of the CV, qualifications and publications<sup>1</sup>
- 70 points out of 100 for the evaluation of the interview<sup>2</sup>

Based on art. 4 of the call, the evaluation committee decided that only those candidates who have achieved a score of at least 25 points for the evaluation of the CV, qualifications and publications will be admitted to the interview stage.

In evaluating CV, qualifications and publications the Committee took particular notice of the specific requirements of this call (as stated in art. 2 – Admission Requirements), and namely some documented experience with ORBIS/firm-level data, and some knowledge of productivity estimation models and techniques (STATA).

The committee takes notice that, with an electronic communication sent to the administration office on July 31<sup>st</sup> at 10.12am, the Candidate **Omissis** has withdrawn his application.


