

COMMITTEE FOR THE COMPARATIVE EVALUATION OF THE CONFERRAL OF N.2 COLLABORATION CONTRACTS AT THE DONDENA RESEARCH CENTRE OF BOCCONI UNIVERSITY (CALL N. 6999)

MINUTES

The evaluation committee composed of Prof. Marco Bonetti (President), Prof. Francesco Billari (Secretary) and Prof. Alessia Melegaro (Member), nominated on 3^{rd} of April 2019 prot. N. 9004, met on 10^{th} June 2019 at 5.30 p.m. via conference call

We received n.2 applications:

1) Vytenis Juozas Deimantas

Omissis

3) Giorgio Piccitto

To be admitted to the competition of the position n. 1 candidates must be in possession of the MSc degree in Economics and/or Social Sciences, while for the position n. 2 is necessary, at least Bachelor Degree.

For this reason, the commission decide to evaluate separately the two positions, but to consider candidates who have the prerequisites for the position one. For this reason, candidates Vytenis Juozas Deimantas and Giorgio Picciotto have been considered both for position n.1 and for position n.2 while the candidate Eugenio Paglino has been considered only for the latter.

According to the regulations of the competition, the Committee has concluded that the maximum scores to be allocated are as follows:

- \cdot 40 points out of 100 for evaluation of the CV, qualifications and publications
- 60 points out of 100 for the evaluation

Only those candidates who achieve a score of at least 21 points for the evaluation of the CV, qualifications and publications will be invited to interview.

Having evaluated the applications submitted, the Commission has allocated the following scores:

According to the criteria listed in the advertisement, the candidates **Vytenis Juozas Deimantas** (for the positions 1 and 2), **Giorgio Piccitto** (for the positions 1 and 2) and **Omissis Omissis** (for the position 2) have been admitted to the interview that will take place on June 26, 2019 at 8.45 a.m.

The meeting concludes at 6.15 p.m.

The Committee met on 26 of June 2019 at 8.35 a.m. at Bocconi University (Via Roentgen, 1), prof. Bonetti via conference call. At the beginning of the meeting, the secretary prof. Billari communicate that on 25 June 2019 Omissis wrote his decision to renounce to the selection.

The Committee confirms that the interview of the candidate **Giorgio Piccitto** took place on June 26 at 8.45 a.m. at Bocconi University.

The Committee asked the candidate a set of questions relating to his CV and to the project he presented.

At the end of the interview, and upon the departure of the candidate, the Committee, unanimously expressed an entirely favorable evaluation as the wide and demonstrated knowledge. The Committee assigned to the candidate a score of 45 points.

The Committee asked the candidate a set of questions relating to his CV and to the project he presented.

At the end of the interview, and upon the departure of the candidate, the Committee, unanimously expressed an entirely favorable evaluation as the wide and demonstrated knowledge. The Committee assigned to the candidate a score of 45 points.

The commission declares dott. **Giorgio Piccitto** and dott. **Vytenis Jouzas Deimantas** the winner for the two position.
