

## MINUTES

### COMMITTEE FOR THE COMPARATIVE EVALUATION OF THE CONFERRAL OF N.1 COLLABORATION CONTRACT AT THE DONDENA RESEARCH CENTRE OF BOCCONI UNIVERSITY

The evaluation committee (nominated on il 03/12/2019, prot. n. 19119) composed of Prof. Andrea Colli (President), Dr. Stefan Nikolic (Secretary) and Prof. Tamás Vonyó (member), met on 3<sup>rd</sup> December 2019 at 10:00 am in office 3.C2.01 in via Roentgen, 1, Milan.






