# WHAT IS THE FUTURE OF INFRASTRUCTURE? GLOBAL CHALLENGES IN A FAST CHANGING ENVIRONMENT

Recent estimates indicate an infrastructure need of about USD 57 trillion worldwide from now to 2030. The infrastructure gap generates a potentially huge demand for greenfield and brownfield investments. While financial markets have developed solutions to convey private capital to this alternative asset class, a number of macro trends are reshaping the sector and the characteristics of the infrastructure universe. Looking forward to 2030, it is clear that what we know today as will be subject to a radical transformation. The Lectio Inauguralis aims to raise awareness in the business community on the future trends affecting the infrastructure sector and on the challenges these changes pose to academics and professionals involved in the field.
