

## MINUTES OF THE SELECTION COMMITTEE MEETING OF THE COMPETITION FOR THE CONFERRAL OF N. 1 PRIVATE LAW CONTRACT OF A FIXED-TERM "LECTURER" FOR THE COMPETITION SECTOR 13 / A2 ECONOMIC POLICY AT THE DEPARTMENT OF "SOCIAL SCIENCES AND POLITICS" OF THE LUIGI BOCCONI UNIVERSITY OF MILAN

### Minutes n. 1

The Committee meeting, convened by prof. Andrea Colli, Director of the Department of Social and Political Sciences, was held on Friday, January 28<sup>th</sup> at 9.00 am via conference call.

The Committee is in charge of the comparative evaluation for the conferral of n. 1 fixed-term private law contract as "Lecturer", announced by the Luigi Bocconi University on December 16th, 2021, prot. n. 24863, for the competition sector 13 / A2 ECONOMIC POLICY, for the evaluation of the applications received and the identification of candidates to be admitted to a trial academic lesson.

The Committee takes note that n. 4 (four) applications have been duly submitted. The applications have been analyzed based on the criteria expressed in the competition announcement. In order to possibly invite candidates to attend an academic lesson to conclude the comparative assessment, the curricula, the list of publications and the qualifications presented by each were preliminarily evaluated.

The teaching profile required by the announcement regards courses concerning the grouping of "Economic Policy". In light of the educational needs expressed by the Department of Social and Political Sciences, the Committee takes in special account the candidates' qualifications, in particular a Ph.D. title in a relevant disciplinary area, as well as the candidates' skills and teaching experience in the area of International Economics, with particular attention to the process of European Integration, from both a theoretical and a policy perspective. The Committee also

considers a significant teaching experience, delivered both in Italian and English languages, as an element of evaluation.

Based on this evaluation, the Committee formulates the following judgments:

BELLODI Luca, born in Bondeno (FE, Italy) on 01/05/1992.

The candidate is a Ph.D. candidate in Political Science at the University College of London. The candidate holds a top publication in this field. He has some limited teaching experience in English in the area of Public Policy and Quantitative Methods. The candidate is a very promising scholar, with qualifications and experience that however do not fully match the teaching profile required by this call.

BONACORSI Laura, born in Bologna (Italy) on 02/04/1987

The candidate holds a Ph.D. Economics at Boston College, with a thesis in international trade. She has been a research fellow at Fondazione Eni Enrico Mattei (FEEM), and currently she is a post-doc researcher at Università Bicocca. She has been teaching Economic Policy, Public Economics, Micro and Macro Economics and International Economics, both in Italian and English, at several universities (Bocconi, Cattolica, Statale Milano, Boston College). The candidate has extensive teaching experience both in Italian and in English in all the areas required by this call.

ELEWA Aya, born in Cairo (Egypt) on 03/02/1991

The candidate holds a Ph.D. Economics at Paris School of Economics, with a thesis in international trade. Currently he is a post-doc researcher at Economics Lab of Orléans. He has been teaching International Economics and Microeconomics as assistant professor at the The British University in Egypt. The candidate has a good teaching experience in English in some of the areas required by this call.

JALLOW Assan, born in Gambia on 17/10/1993

The candidate is a Ph.D. candidate in Economics and Finance at Tor Vergata University. He has been a Lecturer at the University of The Gambia in the areas of Mathematical Economics and Advanced Microeconomics. The candidate has adequate teaching experience in English in some of the areas required by this call.

Following the expressed judgments, the Committee decides to admit the following candidate to the trial academic lesson (scheduled for February, 10<sup>th</sup> at 9.00 am in Bocconi, via Sarfatti 25, second floor, Aula 204 and on Teams):
