With reference to the latest provisions contained in the legislation on the subject of countering and containing the spread of Covid-19,

hereby declare:

1. I am aware of the obligation to stay at home in the case of fever (over 37.5°C) or other flu symptoms.
2. I undertake to respect all the provisions of the Authorities and the behavioral measures established by Bocconi when accessing Bocconi premises (in particular, maintaining a safe distance, complying with the rules of hand hygiene and maintaining correct hygiene behaviors).
3. I undertake to promptly and responsibly inform the Bocconi Departments involved in the case of any flu symptoms during my stay in Bocconi premises, making sure I remain at an adequate distance from the people present.
4. I am aware that I may be subject to a body temperature check at the entrances of Bocconi buildings and, if this temperature is higher than 37.5°C, I will not be allowed access.
5. I understand that I will not be able to enter the premises of Bocconi University if I am subject to isolation and I will have to respect all the conditions provided by the regulations in force at the time before entering the premises of Bocconi University.
6. I am aware that in Bocconi buildings access is allowed only to persons in possession of a Covid-19 green certification ("Green Pass") or equivalent document: I undertake to gain access only in compliance with this condition, and to show the certification in case of checks by the staff in charge, which may also include the control of my identity card.

## Privacy Policy

Pursuant to Article 13 of Regulation (EU) 2016/679 on personal data protection ("GDPR"), current national privacy laws ("Privacy Laws") and the measures in place to manage the COVID-19 emergency, Università Commerciale "Luigi Bocconi" ("Bocconi University") hereby informs you that your personal data shall be processed, using electronic and manual tools.

This privacy policy was drawn up in compliance with the principle of transparency and the requirements under the GDPR. It is spread out over individual sections that will each deal with a specific aspect to provide a more reader friendly document ("Privacy Policy").

### Who is the Data Controller?

The data controller is Università Commerciale "Luigi Bocconi".

### Data Protection Officer

Bocconi University has appointed a Data Protection Officer ("DPO"). Pursuant to Article 38(4), for any matter regarding the processing of your personal data and to exercise your rights under the GDPR you may contact the DPO at the following e-mail address: [dpo@unibocconi.it](mailto:dpo@unibocconi.it).

### The Legal Basis for Processing Personal Data

The legal basis is constituted by the legal obligation and in particular the implementation of anti-contagious safety protocols required by the measures issued for the management of the Covid-19 emergency

### Purposes and Processing of Data

The personal data, i.e. your body temperature, shall be processed for the purposes of containing the spread of COVID-19.

The processing shall be carried out by personnel which are authorized to process personal data so as to ensure the proper processing of data necessary to pursue the purposes under this Privacy Policy.

The personal data shall not be disclosed or disseminated to third parties unless required under specific regulatory provisions, and shall not be stored, subject to any legal obligations.

The processing of data is mandatory for the purposes above. If you refuse the collection of the above data, you will not be permitted to enter the premises.

### Storage of processed data

The data will be kept only if the body temperature measured is higher than 37.5° and only if it is necessary to document the reasons that have prevented access to company premises. Otherwise, the personal data collected will not be stored in any way. If data is kept, it will be kept until the end of the state of emergency.

### Data Subject's Rights

Please note that you may exercise your rights under the GDPR, for instance you may request access to your personal data or request that your data be rectified or erased, or restrict or object to the processing of personal data that concerns you (Articles 15 *et seq* GDPR).

If you believe that the processing of your data is being carried out in breach of any Privacy Laws, you may lodge a complaint with the relevant data protection authority (Italian Data Protection Authority), in accordance with Article 77 of the GDPR.
