

41026: Representation in Contemporary Democracies
Professor Lanny Martin

Overview. This is a PhD seminar on the politics of representation in contemporary democracies. We begin the course with a discussion of different forms, and contending models, of political representation. In the remainder of the course, we examine how electoral, legislative, and executive institutions affect the quality of representation, specifically in terms of how well they fulfill two objectives: (1) producing representatives who act in accordance with the preferences and interests of the citizens who elected them, and (2) providing mechanisms for citizens to sanction representatives who fail them. Focusing on the first objective, we examine theoretical and empirical research on electoral rules, party competition, descriptive representation, citizen-representative congruence, and policy responsiveness. Focusing on the second objective, we examine research on government/legislative performance and electoral accountability.

Evaluation. The course grade will be awarded based on completion of either a research project *or* an extensive literature review on an assigned question relating to representation (50%) and class participation (50%). To engage effectively in class participation, students are expected each week to bring a set of questions pertaining to the assigned readings, which we will address in our discussion. These questions should be uploaded to Blackboard the evening before class convenes.
